CRITERIA FOR SELECTION

For a trainer to be considered for deployment to TVET CDACC, he/she must have the following minimum requirements:-

1. Research

Number of positions –Six (6)

The individual should:

- i. Be a registered trainer;
- ii. Have been a trainer in a TVET Institution for at least five (5) years;
- iii. Have a Master's degree in Education or a TVET related area;
- iv. Have a Bachelor's degree in Education or a Higher National Diploma (HND) in a TVET related area or a Bachelor's degree with PGDE/Technical Education Training;
- v. Have competence in development of research proposals, data collection tools, data analysis and reporting;
- vi. Be trained in Competency Based Education and Training (CBET) and Competency Based Assessment (CBA) by TVET CDACC or KSTVET; and
- vii. Have competence in computer based data analysis (this will be an added advantage).

2. Curriculum Development

Number of positions –Eleven (11)

The individual should:

- i. Be a registered trainer;
- ii. Have been a trainer in a TVET Institution for at least five (5) years;
- iii. Have a Master's degree in Education or a TVET related area;
- iv. Have a Bachelor's degree in Education or a Higher National Diploma (HND) in a TVET related area or a Bachelor's degree with PGDE/Technical Education Training;
- v. Have participated in Curriculum Development processes;
- vi. Be trained in Competency Based Education and Training (CBET) and Competency Based Assessment (CBA) by TVET CDACC or KSTVET and
- vii. Have competence in computer based data analysis (this will be an added advantage).

3. Assessment and Certification

Number of positions –Fifteen (15)

The individual should:

- i. Be a registered trainer;
- ii. Have been a trainer in a TVET Institution for at least five (5) years;
- iii. Have a Master's degree in Education or a TVET related area;
- iv. Have a Bachelor's degree in Education or a Higher National Diploma (HND) in a TVET related area or a Bachelor's degree with PGDE/Technical Education Training;
- v. Have participated in CBET Assessment processes;
- vi. Be trained in Competency Based Education and Training (CBET) and Competency Based Assessment (CBA) by TVET CDACC or KSTVET; and
- vii. Have competence in computer based data analysis (this will be an added advantage).
