## EXPRESSION OF INTEREST (EOI) FOR PROVISION OF RECOGNITION OF PRIOR LEARNING (RPL) RELATED SERVICES (CONSULTING SERVICES – FIRMS SELECTION)

#### 1. INTRODUCTION

TVET CDACC in line with its mandate if conducting competence-based assessment intends to register firms in the provision on RPL related services.

#### 2. OBJECTIVE

The objective of this Expression of Interest (EOI) is for TVET CDACC to receive information from experienced firms that demonstrate capability and experience to provide RPL related services specifically on labour market information, RPL awareness and Publicity, Counselling and Facilitation and general experience in lifelong learning.

#### 3. BIDDING TIMELINE

This Expression of interest will result in short listing of interested firms who will be invited to submit technical and financial bids. Eligibility to participate in the bid process will be determined on the basis of submission of the minimum required documents stated in this Expression of Interest.

After the deadline for submission of responses, Evaluation process will be conducted to determine responsive bids as per the evaluation criteria provided in the Expression of Interest document. The bidders who participate will be notified of the outcome of the evaluation.
