TENDER NOTICE FOR EXPRESSION OF INTEREST

TVET CDACC is a State Corporation established under the TVET Act. No 29 of 2013 whose mandate is to undertake Curriculum Development, Assessment and carry-out Competence Certification as a Qualifications Awarding Institution (QAI) in the TVET sub-sector.

In line with the above mandate the Council intends to publish learning guides to enhance CBET implementation. To support this exercise, the Council seeks to engage the services of a publishing firm to;

- a) Develop, publish, print and distribute learning guides for curricula offered by TVET CDACC and/or
- b) Edit, publish and print learning guides developed by TVET CDACC.

TERMS OF REFERENCE (TOR)

EXPRESSION OF INTEREST (EOI) FOR DEVELOPING PRINTING, PUBLISHING AND DISTRIBUTION OF CBET LEARNING GUIDES (CONSULTING SERVICES – FIRMS SELECTION)

a) INTRODUCTION

TVET CDACC in line with its mandate of conducting competency-based assessment and certification intends to pre-qualify firms for the provision of developing, printing, publishing and distribution services for CBET learning guides.

b) OBJECTIVE

The objective of this Expression of Interest **(EOI)** is for TVET CDACC to identify and shortlist qualified and experienced firms with the capability to provide high-quality developing, printing, publishing and distribution services for CBET learning guides.

c) BIDDING TIMELINE

This Expression of interest will result in short listing of interested firms who will be invited to submit technical and financial bids.

Eligibility to participate in the bid process will be determined on the basis of submission of the minimum required documents stated in this Expression of Interest.

After the deadline for submission of responses, an Evaluation process will be conducted to determine responsive bids as per the evaluation criteria provided in the Expression of Interest document, bidders who participate will be notified of the outcome of the evaluation.

d) EVALUATION CRITERIA

The Expression on Interest received will be evaluated in accordance with the set criteria in the provided Table as follows: -
